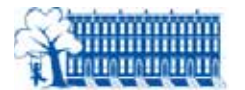

Designations made to the Johns Hopkins Neighborhood Fund will enable nonprofit organizations to build stronger neighborhoods by addressing needs in the areas of health, education, public safety, employment and community revitalization.

Nonprofit agencies that serve the communities situated in close proximity to our campuses and that are associated with Johns Hopkins through employee and/or institutional involvement will be considered for funding through a proposal process.

The financial and volunteer contributions made by Johns Hopkins and its employees will help those in need through local organizations— together we can create stronger neighborhoods.

**United Way of Central Maryland has several opportunities to take advantage of special giving programs.**

**The Weinberg Leadership Society Challenge Grant**, generously sponsored by the Harry & Jeanette Weinberg Foundation, helps donors who give a minimum of \$750 become members of the society by increasing the donation to \$1,000 with the understanding that the donor will contribute the full \$1,000 the following year. The Tocqueville Society Challenge Grant is similar and allows donors who give a minimum of \$5,000 to reach the \$10,000 mark the first year.

Weekly deductions make joining one of these giving programs easy and affordable.

### Leadership Society

- Gold Level \$5,000 – \$9,999
